Pavilion Project - Mrs Grimwood had recently attended a fund raising fair on community buildings with presentations and representatives from Cambridge ACRE and officers of S.C.D.C. The Parish Council, as landowners, would have to apply for any lottery-funded application. In addition to Mrs Fallon, the Parish Council agreed that members rotate on the Pavilion Project Committee and Mrs Course agreed to attend the next follow up meeting which is due to be held in the last week of October.

## 4. Members' declaration of interest for items on the agenda, which may cause a conflict of interest

There were no declarations.

#### 5. Report from District Councillor

- (i) Elin Way: Mr Tim West, Development Manager at Raglan Housing Association Ltd. has confirmed that commencement of building work should be in place by the middle of October.
- (ii) West Way: a resident has complained about litter. The P.P.I.T. will include an article on Pavement Wardens in the

November edition of Meldreth Matters. At present a warden is required for West Way and Kneesworth Road.

(iii) Overgrown hedging: the Clerk has written to First Capital Connect on several occasions to ask for hedging to be cut

parallel to the railway bridge footpath and in the Station Car Park. The Parish Council is most grateful to the volunteer who is cutting back some of the foliage near the railway bridge footpath.

- (iv) Local Elections System public consultation: The motion has been withdrawn.
- (v) Mettle Hill abandoned caravans: Mr Marks, Enforcement Officer, S.C.D.C. has assured Dr van de Ven that he has

the matter in hand.

(vi) Gypsy and Traveller site provision in South Cambridgeshire – public consultation: for the annual travellers count,

Showmen sites need to be defined as 'Travellers Sites' to present a 3 site criteria for Meldreth.

(vii) Flooding:

Dr van de Ven thanked Mr Terry Dash, riparian owner in Chiswick End, for carrying out extensive investigative work on his network of drains. No major blockages found.

Mr Matthews has confirmed that the Elin Way affordable housing development will not be connected to the already over-burdened Whitecroft Road drainage system.

A preliminary enquiry on the Chiswick End problem was raised at S.C.D.C.'s Scrutiny Committee in September with questions to the Environmental Health Portfolio Holder and Services Director. The Portfolio Holder noted that northern areas of the district -Willingham, Swaffham and Waterbeach, have long had their own internal drainage

boards to address flooding issues.

Dr van de Ven and the Working Party have compiled a report outlining the immediate short term and the serious long term aspect whereby authorities responsible for water are not authorised to unite to solve the problem. Dr van de Ven reported on the overall responsibilities of S.C.D.C.'s Scrutiny Committee, which if it agrees, can then summon representatives from the Environment Agency and Anglia Water, together with District Council officers, to a special scrutiny. The District cannot scrutinise the County; it would be up to our County Councillor to pursue such an exercise. Dr van de Ven believes authorities have a moral obligation to the flooding problem.

Though the main focus has been in Chiswick End, the High Street also needs tackling. The County Council is responsible for a number of drains in the High Street and together with individual riparian owners, must work to prevent future problems – this again is a matter for the County Councillor.

#### **6.2** Recreation Ground:

#### 6.2.1 Clearing of ditch

Mr Burlton had obtained an estimate from R.G.T. Groundworks for £623.00 to carry out this work and considers that with annual maintenance it could remain clear for up to 4 –5 years before another major clean. It was proposed by Mrs Fallon, seconded Mr Chamberlain, that the estimate from R.G.T. Groundworks be accepted. All were in agreement. Mr Burlton agreed to dispose of excess soil.

## 6.4 P.P.I.T – update

Six meetings, two public displays and surveys including the involvement of professionals for advice on the Disability Discrimination Act have enabled 18 of the original 34 actions from the Parish Plan to be achieved:

Follow up work experience opportunities with Melbourn and Bassingbourn Village Colleges.

Highways – Pavement Volunteers alerted Clerk to recent problems; footpaths – Parish Paths Partnership volunteers very active.

Improved signage – Pavement Volunteers continue to monitor.

Streams and meadows – in hand via the Melwood Conservation Group and the newly formed Meldreth River Restoration Group.

Litter reduction: Pavement Volunteers to assist Parish Council Litter Collector.

Seats: reviewed current provision of seats/benches in the village and prioritised improvements.

Neighbourhood Watch: improved liaison with Melbourn Police Station and Community Beat Manager.

Social Car Service: recruitment of 10 new drivers with 17 drivers willing to help Good Companions and Luncheon Club. (Mrs Course enquired if there was an age cut-off point for drivers belonging to the Royston & District Community Transport. Councillors were unsure).

Ensure SCOPE remains fully integrated in the village.

Affordable housing: increased provision of affordable and private housing.

Melbourn Surgery: some improvement to services in recent months.

Retention of Post Office: work done by the Team to lobby hard and consistently to retain the facility, valued by villagers and businesses alike.

The P.P.I.T. is not a permanent body and will be disbanded by 31st March 2007. The Parish Council

was asked to sign 18 items from the list. It was proposed by Mrs Course, seconded Mrs Fallon that the 18 items be signed off. All were in agreement. At the next P.P.I.T meeting focus will remain on the remaining 16:

A CB postcode; create a Pavement Warden Team to keep pavements clear of parked vehicles, litter and overhanging hedges and to check storm drains; more pavements at key danger spots and improve design of some existing pavements; review effectiveness of traffic calming measures, etc.; heavy lorries in village streets and country lanes; village streetscape – consider introducing stimulus of entry to Best Kept Village competition; improved Pavilion on Recreation Ground; improve communications throughout the village (website, noticeboards) on what is available, where and when; expand use of village facilities for wider range of activities; Pub as a major village focal point; facilities for youth; facilities for the very young; access for 100 disabled and 60 pushchair users; rail services – request for 8-car stops and southbound platform improved access.

Dr van de Ven said that Parish Plans had been invaluable in providing a basis for the Community Strategy.

#### 6.5 Parish Paths Partnership – update

Painting of signposts: Mr Searles has made a start but would appreciate volunteer assistance. Footpath No. 1, Malton Golf Course and Whaddon. Mr Hart has paid a contractor to remove the fallen tree. Possible new link and bridge over River Mel: Mr Chamberlain and Mr Burlton have had discussions with Ms Tucker of C.C.C. the Environment Agency and Melbourn Parish Paths Committee to explain Meldreth's ideas on a possible link to their Recreation Ground. Mr Burlton and Mr Chamberlain will endeavour to make contact with Mr Berry of Melbourn Village College.

Meads Footpath: the post has been resited to the side of the footpath.

Footpath No. 6 behind Flambards Close. Clerk to report to Mr David Piggott that the sign needs to be set in place. Clerk

Hedging on footpath from Station Road leading to Meads footpath. Mr Burlton is disappointed at the standard of work carried out by contractors and will attempt to rectify the area.

- is designed to cause disruption or annoyance
- has the effect of harassing the authority or
- can otherwise fairly be characterised as obsessive or manifestly unreasonable

Arthur Rank Appeal: Mr Chamberlain asked if the Parish Council could make a donation. The Clerk explained the decision of CALC that donations to individual organisations, not for the benefit of the majority of the village, would not be appropriate.
