MINUTES AS YET UNAPPROVED of Parish Council Meeting held **Thursday 6th September 2007**, 7.30 p.m. in The Green Room, Meldreth Village Hall

1. Apologies for absence:

2. To sign and approve Minutes of meeting dated 5th July 2007:

Amendment – Code of Conduct takes effect from 6th September 2007 Amendment – Parish Plan Implementation Team item 6.15 was not recorded – there was nothing to report. Clerk was to give details of a resident who was interested in the footpaths to Mr Chamberlain; this however was for pavements and not footpaths. Mr Land has been in contact with the resident (Mr Patten) who would be happy to help with a survey of the pavements in the village.

The Minutes were signed as a true record. Proposed Mr R A Searles, Seconded Mr C A Land all agreed

3. Members of the public and press are invited to address the Council:

Items discussed

The vandalism which was occurring in Melwood appears to have settled down, though there have been some instances of vandalism in other parts of the village, the police also believe it has quietened. It was felt that communications with the police could be enhanced. It was suggested that residents should attend the Neighbourhood Panels where they can get direct feedback from the police. The next meeting is scheduled for Tuesday 23rd October 2007, 7.30 pm at Gamblingay Village College (to be confirmed) doors open 7.00 pm

4. Members' declaration of interest for items on the agenda, which may cause a conflict of interest:

There were no declarations of interest.

5. Report from District Councillor:

- A report was made on the results of a Standards Board investigation.
- The bicycle wheeling channel has been installed at Meldreth Station. Cllr Van de Ven has arranged to meet the County Cycling Officer on site to deal with some teething problems.
- Cllr Van de Ven attended a presentation by the County Council on its plans for a bid to the Transport Innovation Fund. The potential for a congestion charge in Cambridge was discussed, together with possible improvements to public transportation in and around Cambridge.
- Speed limits in Bassingbourn/Whaddon Roads: Cllr Van de Ven spent some time over the summer visiting residents in Burtons, West Way and the Showmen's sites to try and determine a rough figure of numbers of school aged children. The number is very high. She wrote to Highways indicating concern that these children lack a safe route to our local schools. A reply was received saying that Meldreth had been signed off from the Safer Routes to School scheme after improvements in 2004, but if the primary school wanted to put in a new application they could do so. Cllr Van de Ven would explore further this and any other possible routes.
- Cllr Van de Ven has made contact with the Woodland Trust regarding maintenance of woods in Meldreth ward
- She attended the first Melbourn Neighbourhood Police Panel, together with Mr Borgonon.

6. 6. Agenda items:

6.1 Speedwatch

After much correspondence it now appears that this scheme is no longer available to villages in Cambridgeshire. Mr Borgonon has written to Cllr McCraith and the Clerk has contacted Andrew Lansley MP to see what can be done. To be discussed when a reply has been received from Andrew Lansley MP. It was suggested that a site visit with Mr Mike Cooper and Mr David Lines from Highways (CCC) should be arranged to look at the trouble spots throughout the village. Clerk to write requesting this. There is some evidence that not all accidents/incidences are being reported to the police and therefore will not be on record. Mr Chamberlain suggested that a short summary of what the Parish Council has achieved in speed control initiatives and where action was being hampered be put in Meldreth Matters.

6.2 Village Hall Car Park

Specifications still need to be drawn up and then three new quotes need to be asked for. Mr Burlton will enquire about getting a consultation done in order to draw up a specification.

6.3 Allianz Cornhill Policy

This is still ongoing and will be discussed in more detail in March 2008. The insurance for the pavilion has been increased to £70,000.

6.4 Recreation Area

There has been some correspondence concerning lack of shade in the recreation area. In the past trees have been planted but unfortunately they have been destroyed by vandalism. At the moment there are no plans to

build shaded areas and the idea of a paddling pool, due to rigorous health and safety issues cannot also be considered. If residents have any other suggestions the Parish Council would be interested to hear.

6.5 Pavilion

Mrs Fallon still to meet with Mrs Grimwood. Insurance has been increased to 70,000.00

6.6 Public Speaking

It was agreed to have a time limit on public speaking to 3 minutes per item. If there is more than one person wishing to speak on a particular item then a spokesperson needs to be nominated. Councillors may ask questions for clarification and the Chairman may close the meeting. The time in total should not exceed 15 minutes

6.7 Freedom of Information Act - Data Protection

Clerk will circulate information.

6.8 Litter Picker

The probation period has now been satisfactorily completed and it was agreed to raise the hourly rate. Proposed by Mr Borgonon, Seconded by Mr Hawkins all agreed.

6.9 Mary Course Memorial

Mr Searles reported that Meldreth Primary School supported the idea of a Community Award for the school. This needs to be discussed with Mrs Course's family. To be discussed at the next meeting.

6.10 Flooding/Drainage

Even with the increase in rain over the past weeks it appears that there has not been any major concerns over flooding. There is a ditch on the corner of Whitecroft Road/ Station Road, which appears to need cleaning. Clerk to make enquiries. The overhanging trees on this corner may also be contributing, Clerk to contact Mr Mike Cooper, Highways Department CCC.

6.11 Burial Ground

Clerk to put up a public notice with contact details of the parish office. This is for visitors, if they need to report loose stones, to contact the parish office immediately. Working party consisting of Mr Land, Mrs Fallon and Clerk to arrange a meeting at the burial ground.

6.12 Parish Paths Partnership (P.P.P) Footpaths and bridleways

- 1. a) Path 6 chippings have been laid by working party on 21st July 2007.
 - b) Grass cutting by CCC has now been carried out on path 6 between the railway and the A10 bypass. CCC contractor have cut the verges on Meads path but needs to be done again.
 - c) Mr Chamberlain has received a complaint from a non-resident concerning the Meads path, but was unable to respond, as they did not leave any telephone contact details.
